## PARISH FINANCE COMMITTEE REPORT YEAR ENDING 31 DECEMBER 2015

Parish Finance records were the subject of an audit by the Archdiocesan Finance Administrator, Helen Delahunty, on November 6<sup>th</sup>, 2014. The following areas of work were investigated:- bank deposits, counting and banking church collections, bank reconciliation, planned giving, credit payments, balance sheet reconciliations, long service leave accrual, GST and BAS processes, finance committee.

Mrs Delahunty commented that "the office is very well organised, and we had easy access to the information needed to finalise the audit".

The Income and Expenditure report given shows the 2014 figures in comparison with the 2013 figures approved by the audit. Parishioners who have questions pertaining to this report are encouraged to refer them to any member of the parish finance committee.

It has been a demanding year for the finance committee which is to be complimented on its dedication and application to somewhat difficult tasks. On your behalf I would like to thank committee members Bill Luchetti, Mark Valencic, David Garland, Stan Waldren, Sam Longley and our parish secretary Irene Carr for managing the variety of tasks that were encountered by the parish.

Reroofing of the Hartigan Centre/School and the restoration of the Hartigan Centre verandah are now complete. The Lovat Chapel and associated kitchen and green room are also completed thanks to an enormous effort from Bob Nash. The parish owes him a debt of gratitude.

Construction of the Dutton Street townhouses has been the subject of much discussion and many meetings. It is expected that the town houses will be finished by the middle of June. It is appropriate that we acknowledge Warren Ahrens, John Sykes and foreman Nathan and staff of PBS builders for their co-operation, courtesy and expertise throughout the project. They have produced a high quality development which parishioners can be proud of. Regretably construction costs have exceeded estimates due to a large amount of necessary rock excavation and extra Yass Valley Council charges. Consequently the project will not be as profitable as originally projected because the selling price will be dictated by present market forces. It will, nonetheless, produce some much needed funds for the upkeep of our beautiful buildings.
