 - Arising from last meeting's minutes was the comprehensive list of duties in the Maintenance portfolio, which lead to:
 - a. the requirement for each portfolio to have a duty statement
 - b. the need for the Maintenance portfolio to have an active committee, to ensure that all tasks are not left with one person
 - Each PPC member was asked to draft the duty statement for their portfolio, and once endorsed these will accompany the PPC Charter as a guide for prospective portfolio holders.
 - Note that the duty statements do not mean the portfolio holder has to personally undertake each task, but they are responsible for it being attended to.
 - Management of Maintenance Portfolio
 - The required tasks and issues Bob has set out can be divided into different sections:
 - eg. 1. Matters regarding events in the Lovat Chapel

- 2. Maintenance tasks relating to each building
- o Bob informed us that the biggest tasks include:
 - the supervision of building/large scale maintenance projects that require the presence of contractors.
 - Moving items /equipment necessary for events.
 - Liaising with Lovat Chapel/Hartigan Centre event organisers.
- The number of tasks requiring attention in the Maintenance portfolio means that there are tasks that are being delayed, which in turn is preventing the use of space in the old convent building. Local Real Estate agents indicate they would be able to lease these spaces with no trouble, but they are not currently compliant with safety requirements.
 - Bob has a list of all tasks remaining to achieve compliance; it is roughly a quarter of the way completed.
